Issues explored include the application of professional and clinical reasoning traditional and emerging practice settings, collaborative practice, ethics, licensure, certification, and professional sustainability.

Issues explored include the roles and functions of occupational therapy practitioners; participation in professional organizations; and professional sustainability.

This course provides the background for understanding the influence of neurologic and orthopedic pathology on activities and routines of daily living, and participation in society.

2. Course Title: Human Performance Compensation (HRS 2514) – 3 credits  
Position: Course Instructor: (2015)

Contact Hours; Number of Lectures and Laboratory experiences: 5 hours per week; 32 lectures (16 week term)  
Description: This course examines the interface between functional impairment, activity, and societal participation. The emphasis is on person-task-environment analysis and adaptation to compensate for dysfunction during self-care, home management, school/work, and play/leisure occupations.
3. Course Title: Analysis of Clinical Data: Evidence of Functional Change (HRS 2582) – 3 credits  
Position: Course Instructor: (2012 – 2015)  
Year(s), number of students: Fall 2012, 5 MS students; Fall 2013, 7 MS students; Fall 2014, 9 MS students  
Contact Hours; Number of Lectures: 3 hours per week; 11 lectures (16 week term)  
Description: This course focuses on how to design and carry out single-subject design (SSD) studies and use visual, semi-statistical and statistical methods of analysis (level [mean], trend [acceleration lines], 2 SD band, C-statistic) to document functional changes in client performance.
4. Course Title: Human Performance Adaptation (HRS 2503)—3 credits  
Position: Course Instructor (2013 – 2014)  
Year(s), number of students: Spring 2013, 2 MS students; Spring 2014, 10 MS students  
Contact Hours; number of Lectures: 3 hours per week; 14 lectures (16 week course)  
Description: The substance of this course is the research evidence that supports human performance adaptation for function. Occupational therapists and other rehabilitation practitioners tend to use three approaches to human performance adaptation: restoration, compensation, and education. The scientific evidence that supports these rehabilitative approaches, as well as other approaches to adaptation, is the focus of this course.
