CURRENT RESEARCH INTERESTS

Untreated hearing loss in aging adults is associated with poor social and health outcomes. There is emerging evidence that treating hearing loss positively impacts both social and health outcomes in this population. Hearing loss appears to be a modifiable risk factor for a number of issues in aging including cognitive decline, hospitalization, readmission, medical adverse events, and social participation. Only 23% of aging adults have had their hearing screened or tested and only 18% make use of amplification which is the evidence-based treatment for hearing loss. My research is focused on identifying delivery models that could support the identification of hearing loss and provision of hearing assistance in health care settings where individuals cannot fully participate in decision making if there communication is compromised by hearing loss. Additionally, my research focuses on what elements (resources/personnel) need to be in place to support more individualized hearing health care if indicated.
